BY-LAW NO. 59 FOR 2002

Being a by-law to assign and/or change names of municipal road allowances for a municipal addressing system and for the implementation of an emergency response system.

WHEREAS Section 210 (111) of the Municipal Act, R.S.O. 1990, as amended provided that bylaws may be passed by councils of local municipalities to give names or to change the names of roads and streets and for affixing the names at the corners thereof on public or private property;

AND WHEREAS the Council of the Corporation of the Municipality of Huron East deems it desirable and in the public interest to assign and/or change names of certain municipal road allowances in association with the Municipality of Huron East municipal addressing system;

AND WHEREAS the Council of the Corporation of the Municipality of Huron East has advertised the proposed road naming by-law for four successive weeks in newspapers having general circulation in the municipality and has held a public meeting to consider said by-law in accordance with the provisions of Section 210 (110) (b) of the Municipal Act, R.S.O. 1990, as amended;

NOW THEREFORE the Council of the Corporation of the Municipality of Huron East enacts as follows:

- 1. That municipal road allowances under the jurisdiction of the Municipality of Huron East shall be assigned names in accordance with Schedule "A" attached hereto.
- 2. That all By-Law and/or resolutions which are inconsistent with the provisions herein are hereby repealed.
- 3. That this By-Law shall be registered in the Land Registry Office for the County of Huron (No. 22) in accordance with the requirements of Section 210 (111) (a) of the Municipal Act, R.S.O. 1990, as amended.
