

THE CORPORATION
OF THE
MUNICIPALITY OF HURON EAST
BY-LAW NO. 65 FOR 2014

Being a by-law to temporarily stop up a portion of Sports Drive, Turnberry Street (County Road 12), Ainley Street and Ellen Street within the Brussels Ward, and a portion of Duke Street and Main Street (County Road 12), and Crombie Street, within the Seaforth Ward, Municipality of Huron East.

WHEREAS the Municipal Act, S.O. 2001, c.25, s.42, as amended, authorizes a municipality to delegate to a committee of council or to an employee of the municipality, subject to any conditions which the municipality may impose, the power to close a highway temporarily for any purpose specified in the by-law;

AND WHEREAS the Council of the Corporation of the Municipality of Huron East is desirous of closing specific roads in the Brussels Ward of the Municipality of Huron East to accommodate the Brussels Santa Claus Parade being held November 29th, 2014;

AND WHEREAS the Council of the Corporation of the Municipality of Huron East is desirous of closing specific roads in the Seaforth Ward of the Municipality of Huron East to accommodate the Seaforth Santa Claus Parade being held November 28th, 2014.

NOW THEREFORE the Council of the Corporation of the Municipality of Huron East enacts as follows:

1. Turnberry Street, Brussels Ward (County Road 12) will be closed in accordance with the requirements of the County of Huron dated October 22nd, 2014 as follows:
 - a) Saturday, November 29th, 2014 from 5:00 p.m. to 5:45 p.m. between Sports Drive and Ellen Street, Brussels Ward (Parade)
2. The following streets will be closed for the Brussels Santa Claus Parade on Saturday, November 29th, 2014 between the hours of 5:00 p.m. to 5:45 p.m.:
 - a) Sports Drive from the Brussels Morris & Grey Community Centre to Turnberry Street
 - b) Ellen Street from Turnberry Street to Ainley Street
 - c) Ainley Street from Ellen Street to the Brussels Morris & Grey Community Centre.

3. Main Street, Seaforth Ward (County Road 12) will be closed in accordance with the requirements of the County of Huron dated November 2014 as follows:
 - a) Friday, November 28th, 2014 from 7:00 p.m. to 8:30 p.m. between Duke Street and Crombie Street, Seaforth Ward (Parade)

4. The following streets will be closed for the Seaforth Santa Claus Parade on Friday, November 28th, 2014 between the hours of 7:00 p.m. and 8:30 p.m.:
 - a) Duke Street from Main Street North to Chalk Street North
 - b) Crombie Street from Main Street South to Coleman Street

5. This by-law shall come into force and take effect on the date of final reading thereof.

Read a first and second time this 4th day of November, 2014.

Read a third time and finally passed this 4th day of November, 2014.
