BY-LAW NO. 4 FOR 2015

Being a by-law to repeal By-Law 8-2011 and to amend By-Law 58-2002 (The Huron East/Brussels Community Development Trust By-Law)

WHEREAS the Corporation of the Municipality of Huron East received five hundred and twenty nine thousand and one hundred and fifty dollars and twenty three cents (\$529,150.23) from the sale of the Brussels Public Utility and the existing hydro reserves;

AND WHEREAS the Brussels Public Utility was paid for entirely by the ratepayers of the Brussels Ward through the years;

AND WHEREAS the Brussels Public Utility was an asset of the Village of Brussels, a Ward of the Municipality of Huron East, created on January 1st, 2001;

AND WHEREAS the proceeds of the sale of the Brussels Public Utility and existing hydro reserves have been recognized by the Minister's Order on Restructuring made under the <u>Municipal Act</u> on March 31st, 2000, in Section 10(2) as monies to be received and used for the benefit of the former Village of Brussels;

AND WHEREAS the Corporation of the Municipality of Huron East by By-Law 58-2002 established the Huron East/Brussels Community Development Trust to manage the proceeds of the sale of the Brussels Public Utilities by the Corporation of the Municipality of Huron East to Festival Hydro and to provide for the use of the proceeds in accordance with the provisions in Section 10(2) of the Minister's Restructuring Order;

AND WHEREAS the Council of the Corporation of the Municipality of Huron East is desirous of amending By-Law 58-2002 and repealing By-Law 8-2011;

NOW THEREFORE the Council of the Corporation of the Municipality of Huron East **ENACTS AS FOLLOWS**:

- 1. That Schedule "A" of By-Law 58-2002 being a "Declaration of Trust" be repealed and replaced with a "Declaration of Trust" attached hereto as Schedule "A".
- 2. That in accordance with Section 6 of the Declaration of Trust and the provisions of By-Law 8-2011, that Doug Sholdice, Ralph Watson and Charlie Hoy be appointed to the Huron East/Brussels Community Trust for a term to expire at the end of 2018.
