Bill Dietrich, P. Eng. with Dietrich Engineering Limited, presented the Engineers Report for the Branch 'G' of the Stimore Municipal Drain 2016. Mr. Dietrich noted that the existing Branch 'G' of the Stimore Municipal Drain is in poor state of repair and is neither of sufficient capacity or depth to drain the surrounding and upstream lands within the watershed to current drainage standards The upper portion of the Drain (approximately 550m) is located in the Manley Line road allowance. The Report proposes a new tile drainage system be constructed from the outlet in the Main Drain open portion of the Stimore Municipal Drain in the Spt Lot 5, Concession 12 upstream to the SW corner of Lot 5, Concession 13. The proposed work consists of approximately the installation of approximately 814 metres of 350mm to 450mm diameter concrete field

7:23 p.m. – Deb Homuth, Co-Chair, South Huron Hospice Steering Committee – Jessica's House Deb Homuth, Co-Chair of the South Huron Hospice Steering Committee and Maria Hamather,

attended before Council to request support for a South Huron Residential Hospice. Council were advised that a Steering Committee has been formed and a business plan has been developed for Jessica's House, a residential hospice to be built in Exeter. Ms. Humoth advised fundraising has begun and a considerable amount of donations including in-kind have been raised to date. Council were requested to provide a formal letter of support for the project and also to consider a financial donation towards Jessica's House during their budget deliberations. It was noted that the Ontario's budget for 2016 contained a significant increase in funds for community hospice palliative care, and specifically the funding of 200 new hospice beds. Ms Homuth noted that the Province will provide \$105,000 annually per bed per for operating costs for LHIN approved hospices and Huron County has been identified as the County most in need of a residential hospice. The South West LHIN has requested funding for 10-12 beds to fund an integrated Huron-Perth solution.

Council noted that correspondence that was included in the agenda package from the South West LHIN provided an update on residential hospice planning in the South West LHIN and advised that a study is being conducted by a consulting firm to understand the current and future needs in Huron and Perth Counties. The correspondence further noted that the Huron Perth Residential Hospice sub-committee will be presenting the report from this study and making recommendations for the local Collaborative to consider on November 23rd, 2016.

Council advised that they would discuss this request later in the meeting.
