

MUNICIPALITY OF HURON EAST
POLICY: USE OF FIRE APPARATUS FOR "VICTORY RIDES"

PURPOSE: To provide a procedure including rules and regulations when fire apparatus is used when giving teams or individuals "Victory Rides".

POLICY: The Council of the Municipality of Huron East authorizes the use of fire apparatus when giving winning sports teams or individuals rides on top of the fire apparatus (Victory Rides). These rides will only be given to teams or individuals that win a Provincial Championship.

PROCEDURE:

In order for the municipality to assume responsibility for these events it must be an approved municipal function. On approval of this policy Council authorizes the CAO/Clerk to approve each ride.


The team or individual requesting the ride must complete a Victory Ride Application Form (see Appendix A). This application form which includes all rules and regulations **must be completed and signed prior to any rides given.** All rules and regulations must be adhered to at all times. If any rule is broken at any point during the ride it will be terminated immediately and all riders will be asked to get off the apparatus and it will return to the station.

A waiver form (see Appendix B) must be completed and signed prior to any rides given. A team representative by way of his/her signature assumes all liability and is responsible for all riders and will ensure all rules and regulations are followed.

Failure to follow this policy by any Municipal Employee including volunteer firefighters will be subject to disciplinary action.

RULES AND REGULATIONS

1. Use of alcohol prior to or during event is strictly prohibited.
2. It is strongly recommended that all rides have a Police Escort to be arranged by the group requesting the ride.
3. No apparatus rides will be given after 6:00 pm. Rides will be scheduled during daytime or weekends only.
4. Two people of legal age will be required to sign a waiver form on behalf of a team or group. These people will take full responsibility and liability for all riders.
5. All riders must be situated within the width of the apparatus. No leaning over sides of truck at anytime.
